8.TIME AS A PUBLIC HEALTH CONTROL

Observations: Major Violation:

TPHC was not maintained. Only Dec. 12 log was observed on site. Once inspector entered the kitchen, employee was directed by owner's husband to write down TPHC time on the TPHC log. But employee wrote down time on the Dec. 12 log. Education provided. Corrected. (3rd Repeat Violation)

Note:

Observed orange sticker for the cooked chicken and green sticker for cooked beef - cold top of the 2 door reach-in cooler upon arrival. Interviewed owner's husband, he stated that orange and green stickers were the same. Food has been storing inside the cold top since 10am this morning. Per owner's husband, cooked beef and cooked chicken will be sold out by 1:30pm. Per owner, different colors stickers should indicate different time for the TPHC items. Owner stated that she will train employee again with writing start time and discard time on the color stickers.

Code Description: When time as a public health control is used, the following procedures shall be observed: food

items shall be marked to indicate four hours past the time when the food was removed from temperature control, food shall be served or discarded within the four-hour time limit, written procedures for food that was prepared, cooked, and refrigerated before time as a public health control was used, shall be maintained at the food facility and be made available to the enforcement agency upon request.
