14: Wiping cloth bucket with zero ppm sanitizer on floor of prep table. Employee stated it was likely from yesterday. Store wiping cloths in sanitizer solution when not in use. This was corrected during inspection. 22: Fried chicken holding at 112F upon arrival. Facility uses time as a public health control for chicken but it was not time stamped and no written procedures are available for review. In order to use time as a public health control, properly time stamp food item and have written procedures available for review. 26: Spray bottle near warewashing area observed unlabeled. Properly label all toxics to prevent contamintaion. 41: Discontinue storing ice scoop on top of machine. Store in a manner that is easily cleanable. 53: Floor tiles are in disrepair in kitchen. Repair or replace flooring so it is smooth, non absorbant and easily cleanable. 56: Post most recent health inspection score (old one from 2021 currently posted)
