Discussed implementing a Risk Control Plan(RCP) in order to obtain active managerial control over repeated Priority Items. Advised operator I was available to assist with developing the RCP.

Items cold holding and toxic items have been found on two consecutive inspection, a third time and the permit could be revoked.

Six ribeyes, 10 10 ounce steaks, 13 6 ounce steaks, 3 anchoo salmon steaks, 11 garlic shrimp bags, quarter pan of fajita shrimp, six bags of shredded meat and full pan of burger bites approx 15 lbs of product thrown away.
