14: Dishmachine is dispensing zero ppm sanitizer. Person in charge contacted maintenance for repairs asap. Ensure dishmachine is dispensing 50ppm sanitizer minimum.
36: Mouse droppings observed in warewash area. Clean and sanitize affected area and monitor for new activity. Potential nesting points are insulation above dish machine and open vents. Consult with pest control and service as needed. 41: Tongs are buried in raw shrimp in reach in unit. Store tongs in a manner to prevent contamination. Store ice scoop in/on an easily cleanable surface to prevent contamination.
45: Gaskets in reach in unit are in poor repair. Repair or replace gaskets. 53: Clean dust accumulation from ceiling in food prep area to prevent contamination. Replace missing ceiling in warewash area. Clean black substance that is appearing as a what seems to be a water leak from ceiling tiles
