1: Lack of active managerial control over general cleanliness and sanitation. Recommend maintaining daily cleaning checklist on cleaning and sanitizing of food and non-food contact surfaces. General cleanliness and sanitation continues to be marked out of compliance on routine inspections.

14: Adequate cleaning and sanitizing frequency not provided. Numerous surfaces dirty throughout kitchen/prep/storage areas. Recommend detailed cleaning regiment to properly maintain sanitation levels daily.

36: Outer openings not protected. Back door left open at time of inspection. Outer openings leading to outside must be protected to eliminate dust and insects from entering establishment.

39: Soiled, wet wiping cloths stored on working surfaces and not in sanitizer solution.
