*5: Several water connections from water source to campers do not have a backflow.

6: Not all sanitation sewer disposal inlets are surrounded by a concrete apron, slopped inward to drain, capped, and four inches above ground for motor homes, travel trailers, or truck campers.

21: Several spaces / camp sites are not identified.

*22: Fire extinguishers must be in all storage and hazardous areas. Missing fire extinguisher where water heater / storage area is located at bathhouse.

*22: Fire extinguisher in office is not tagged. Contract a licensed fire extingusher company to check and tag fire extinguisher.

35: Trash can in women's restroom is not covered and not fire resistant. All trash cans in restrooms must be fire resistant.
