34: Thermometer in walk in cooler not working properly

42: Containers stacked wet on shelf across from 3 comp sink

47: Inside of ric is dirty. Shelves through out kitchen are dirty with grease build up. Shelves in wic dirty

53: Grease and food debris built up on floor along walls and under equipment
